

Minutes of the Troy Township Public Hearing

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Baltz asked for questions or comments from the Board on the Road and Bridge Budget and Appropriation Ordinance 14-15-03.

Supervisor Baltz asked for questions or comments from the Board on the Town Fund Budget and Appropriation Ordinance 14-15-04.

Hearing none, Supervisor Baltz asked for a motion to approve.

Motion made by Trustee Ryan; seconded by Trustee Walden to adopt Ordinance 14-15-03 an Ordinance Appropriating for all Road Purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2014, and ending March 31, 2015, with a total appropriation amount of \$1,271,070.00. Roll call vote: Ryan-Aye; Theobald-Aye; Walden-Aye, Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Ryan; seconded by Trustee Wheeler to adopt Ordinance 14-15-04 an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2014, and ending March 31, 2015 with a total appropriation amount of \$1,018,360.00. Roll call vote: Ryan-Aye; Theobald-Aye; Walden-Aye, Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Theobald; seconded by Trustee Walden to adjourn. Meeting adjourned at 7:06pm.
