An ordinance levying taxes for all town purposes for TROY Township, WILL County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of TROY Township,
WILL County, Illinois, as follows:

SECTION 1: That the sum of One Million Three Hundred and Two Thousand
