GUESTS AND CITIZEN COMMENTS:

Supervisor Baltz opened the meeting for the introduction of guests and citizen comments.

After asking a third time, and hearing none, Supervisor Baltz closed the meeting for citizen comments.

At this time, Mr. Pryor graciously postponed the CED presentation so the Board could move forward with New Business Agenda Item XII:

NEW BUSINESS:

After acceptance by the Board to move the Agenda Item, Supervisor Baltz invited Assessor Kimberly Anderson to recite the Resolution.

Supervisor Baltz then submitted the following item:

A) Approval of Resolution 22-23R-07, a Resolution of the Township of Troy Will County, Illinois Honoring Tamara Schwartz for her service as Chief Deputy Assessor from March 14, 2011, to July 29, 2022. After presentation from Assessor Anderson and Supervisor Baltz, a motion was made by Trustee Kopman; seconded by Trustee Nudera to approve Resolution 22-23R-07, a Resolution Honoring the Service of Tamara Schwartz, as presented.

Supervisor Baltz extended his gratitude and commended the work ethic that Tam Schwartz brought to the Assessor's Office. Baltz also recognized Steve Schwartz as a former employee of the Township and applauded his service as well as efforts to advocate for employee benefits. Rhianna Khorst was introduced as the Chief Deputy Assessor and Tamara was praised for her mentoring/training of fellow employees.

PRESENTATIONS:

Supervisor Baltz introduced Mr. Doug Pryor, President, and CEO of the Will County Center for Economic Development. Mr. Pryor reported that Troy Township is a partner of the Will County CED, which depends on two-thirds private funding to continue promoting regional development and investment (41 years strong).

- Mission Statement: Try to bring jobs and investment to Will County. This mission involves development of all facets, such as infrastructure, quality of life, workforce, lobbying, etc....
- Approximately 16,000 employers in Will County. They make the County the #1 job creator in IL spanning 5-, 10-, & 20-year studies.
- Industrial Real Estate Leasing over the past year is at approximately 28.4 million square feet. Contributing factors include 1) E-Commerce, and 2) Re-shoring (bringing goods closer).
- Occupancy stands at 98% countywide. Troy Township has approximately 14.4 million sq. ft. of space with 0.1% industrial vacancy right now (18,300 sq. ft. available).
- Single family housing in Will County ranks #1 in IL for the last three years.
- Key projects include: Lion Electric vehicle manufacturing facility, Harbor Freight, Amazon (12th facility), Silver Cross Hospital Neo-Natal, Diageo (Plainfield), Houbolt Rd Bridge, IDOT \$2 billion (over 5 yrs.), Energy Sector (electric, solar, hydrogen, nuclear), Cullinan Project

ASSESSOR'S REPORT: Assessor Kim Anderson presented the following:

- A reassessment factor of 6.30% was adjusted again by Will County to apply to all residential properties.
- On August 10, 2022, the assessments were published in the Herald-News. There were 904 notices, with the majority consisting of "new construction". Mailings went out August 6, 2022.
- The appeal season has begun, and the last day to file with the County on September 12, 2022. All appeal information is outlined on the Troy Township website.
- Extended hours are offered by appointment on Thursdays running from 8/11/22 through 9/1/22
- Total exemptions for the year stand at 731, and in addition 491 home improvement exemptions.
- Attended continuing education on the valuation of agriculture buildings in Quincy, IL. Coursework included visitation of nearby farm buildings and will aid in future valuations.
