

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 22-23-11

An ordinance levying taxes for all road purposes for TROY Road
District WILL County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of TROY Township,

WILL County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of TROY Road District
on DECEMBER 19, 2022 does hereby determine and declare that the sum of One Million Six
Hundred Thirteen Thousand Seven Hundred Twenty Dollars & 00/100 (\$1,613,720.00) are hereby levied
upon all property subject to taxation within the Road District as that property is assessed and equalized,
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by
statute or voted by the people in accordance with the law, for such purposes as:



SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for TROY Road District.

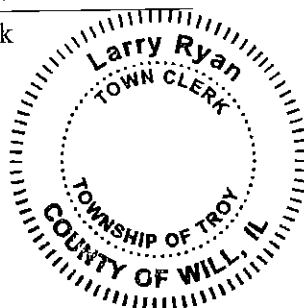


SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.




