

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 22-23-12

An ordinance levying taxes for all town purposes for TROY Township,
WILL County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of TROY Township,
WILL County, Illinois, as follows:

SECTION 1: That the sum of One Million Three Hundred Sixty-Eight Thousand
Four Hundred Thirty-Four Dollars & 00/100 (\$1,368,434.00) are hereby levied upon all
property subject to taxation within the Township as that property is assessed and equalized, in order to
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted
by the people in accordance with the law, for such purposes as:
