TROY TOWNSHIP OFFERS SOCIAL SERVICE PROGRAMS

Everyone needs help sometimes and the Troy Township General Assistance Office is here for you. We have helped many residents throughout the years, and we look forward to a future of assisting those in need.

General Assistance

General Assistance (GA) is a public assistance program mandated by state law for qualified individuals with financial needs. GA can provide monthly payments to help individuals meet basic needs including but not limited to rent and utilities. Individuals can apply at the Township's General Assistance Office. An applicant must be a resident of Troy Township and must meet all financial and nonfinancial eligibility requirements. The General Assistance Office has 30 days from receipt of a completed application in order to make a determination.

Emergency Assistance

Emergency Assistance (EA) is available to qualified individuals and families facing emergencies that are work related or life threatening (i.e. eviction, utility disconnection, and transportation). Those interested can apply at the Township's General Assistance Office. Applicants must be residents of Troy Township and meet financial and non-financial eligibility requirements. The General Assistance Office has 30 days from receipt of a completed application in order to make a determination.

Salvation Army Service Extension Program

Troy Township serves as a Service Extension Unit administering funds for the Salvation Army. Salvation Army funds are earmarked for emergencies and available once in

any 12-month period for qualified residents who live in Channahon, Minooka, or Shorewood. Individuals or families facing a lifethreatening circumstance may be helped using Salvation Army welfare guidelines.

Nicor Sharing

One-time annual grants are given, with no requirement to be paid back, to qualified residential customers who meet the required income guidelines. The Nicor Gas Sharing Program is administered by the Salvation Army and funded through direct contributions from Nicor Gas' customers and employees. The Troy Township General Assistance Office serves as a Service Extension site for the Salvation Army and can serve need, leave what you can." When donating, residents who live in Channahon,

MICRO PANTRY

Township has a "take what you need, leave what you can" micro pantry at the entrance to our building. The micro pantry is supported by donations from local residents. When donations are low the pantry gets filled thanks to our local not-for-profit group Shorewood Hugs. The pantry is available 24 hours a day, 7 days a week. Quadrennial Assessment Year Completed in 2023

Sometimes referred to as a general assessment year, the quadrennial assessment occurs every four years. Quadrennial assessment years are times for the county to take an inventory of all taxable property and investigate them.

During quadrennial assessment years, local township assessors must reassess every parcel in their township regardless of age, location, size, or value of improvements. To do this, my staff and I conducted sales studies in our township and reviewed them for possible changes in value. All properties in Troy Township were considered for a possible change dependent on market value sales as well as uniformity with comparable properties. Troy Township currently has 20,359 parcels located within our borders, so this was no easy job. But it was completed in a timely manner, and I must congratulate my staff on a job well done.

Revised Assessment Notice


Because of the quadrennial assessment year, every parcel within a township's jurisdiction will receive a notice in the mail from their respective county. Please note that there are no exemptions included in the market value on your reassessment notice. Check the back of the notice for a complete explanation and more information.

Will My Property Taxes Increase Because My Assessment Increased?

If your value was increased, it does NOT necessarily mean your property taxes will. Property taxes are the result of the demand of funds for our taxing bodies to fulfill their budget requirements. A property tax bill is figured by the assessed value, minus any exemptions, times the tax rate that is determined by the taxing bodies.



Your Property Record Card and Conducting a Property Search



As always, I encourage everyone to review their property card that is on file with my office. Information on your property can be found online at www.troytownship.com by clicking on the "Property Search" feature on the home page as shown in the image to the left. If an error is found, it can be corrected. If the error would result in a change in your property value, we can go back one year to correct it.

Always check your property tax bill to ensure you are receiving all the exemptions you are entitled to. Missing exemptions that you were eligible for the prior year can be added and a revised property tax bill will be generated. Exemption corrections have to be within one year. Certain criteria must be met to qualify for available exemptions. For a complete list of exemptions and their criteria, please visit our website under the assessor tab and click on exemptions, or please feel free to give us a call.

Exemption Amount Increases

Some exemption amounts were increased by the State of Illinois. These new amounts take effect this year and will be on your 2024 tax bill.

- General Homestead Exemption was \$6,000, increased to \$8,000.
- Senior Homestead Exemption was \$5,000, increased to \$8,000.
- Senior Freeze Income Amount there has been no change to the Senior Freeze income amount for this year.

Township Field Staff

Be aware that from time to time you may see Township field staff personnel out and about throughout our area. Visits are required when you add something to your property like an in-ground swimming pool, detached garage, an addition to your home, etc. These improvements must be added to your property record card. Certain types of improvements may result in an increase in value. If our Field Staff visited your property and you are not there, they will leave a door hanger with information as to why they were there. This door hanger may request that you call the office to set up an appointment. If so, we would appreciate your promptness in contacting our office.

To help you identify our staff, they will be:

- Driving a silver Ford Explorer with the Troy Township logo identified on the doors.
- Wearing Troy Township shirts.
- Wearing an identification tag on a Troy Township lanyard.
- Able to provide you with my business card.

Townships residents are always welcome to visit my office. We are happy to assist you with any questions regarding the value of your home or business, questions regarding exemptions, and assistance in completing exemption paperwork. DECENNIAL COMMITTEE INFORMATION

In 2022 the State of Illinois passed the Local Government Efficiencies Act. This act requires the Township and the Road District to each create a Decennial Committee. Each Committee is required to study the governmental unit's governing statutes, ordinances, rules, procedures, powers, jurisdiction, shared services, intergovernmental agreements, and interrelationships with other governmental units and the State. The committee shall also collect data, research, and analyze as necessary to prepare a report which will summarize its work and findings and shall include recommendations in respect to increased accountability and efficiency.

A MESSAGE FROM HIGHWAY COMMISSIONER Thomas R. Ward

I hope everyone is doing well. As I have in the past, I'd like to remind residents that there is a lot of road construction occurring throughout the Township and local region. Please keep this in mind, and please remind young drivers to be cautious and to go slow in construction zones. School is also now in session so be careful in school zones and watch for school buses. Know that local road construction will likely cause delays so please leave yourself enough time to get to your destination.

Our crews are finishing up their summer projects and we are now preparing for leaf season. The leaf vacuum program is very labor intensive and takes the dedicated involvement of each and every crew member to accomplish. Leaf vacuuming services will typically run through the end of November but may be suspended

due to snow and/or ice events. Please keep in mind, if the snow and/or ice event is significant enough, the leaf vac service could potentially end for the season.

Please read the guidelines below for leaf vacuuming and tree branch pick-up services. These services are extra services we provide which are beyond the scope of our statutory duties. To keep these programs in service and running smoothly we need you to abide by the rules we have established. SERVICES FOR UNINCORPORATED AREAS OF TROY TOWNSHIP



LEAF VACUUMING

Starting the middle of October through November (specific dates are weather dependent), Troy Township Highway Department will have the leaf vacuuming service for residents in the **unincorporated** areas of the Township.

Please <u>do not bag the leaves</u>. Residents must rake leaves to the edge of the street so the vacuum machine can reach them easily. **Do not place leaves in ditches as the vacuum cannot reach leaves in ditch areas.** <u>Grass cuttings will not be picked up as we have no way of disposing them.</u> Please be advised that the leaf vacuuming service may be put on hold with the occurrence of a snow or ice event.



TREE BRANCH PICK-UP

The final pick-up dates for the Tree Branch Pick-Up program in the <u>unincorporated</u> areas of the Township will be Monday, October 2nd, Tuesday, October 10th, Monday, October 16th, Monday, October 23rd and

Monday, October 30th. This service will resume at the beginning of May 2024 on the first and third Monday of each month. For more information, please visit www.troytownship.com.
