BE IT ORDAINED by the Board of Trustees of TROY Township,

SECTION 1: That the Highway Commissioner of TROY Road District
on DECEMBER 18, 2023 does hereby determine and declare that the sum of One Million Seven
Hundred Twenty-Two Thousand Three Hundred Forty-Four Dollars & 00/100 (\$1,722,344.00) are hereby levied
upon all property subject to taxation within the Road District as that property is assessed and equalized,
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by
